




### **Recent history**

## Building Safety Act

Biggest act through parliament in recent times -

## An Act of 6 Parts

- I. Introduction and Scope
- 2. Establishing the new Regulator, Committees and Powers
- 3. Major revision and reform of the Building Act 1984 (England & Wales) including the definition of higher risk buildings 4. The new Higher Risk Buildings Regime in operation (residential) 5. Construction Products, Architects Registration (UK wide) 6. Technical clauses relating to liability, Crown Application, transitional arrangements and other legal provisions The Act also contains enabling provisions relating to the costs of building remediation

Plus several schedules





## **BSA Implications**

Creation of the building safety regulator A new approach for all construction (inc high rise residential) Surveillance and sanctions powers Liability backward and forwards OPSS focusing on product areas Several new committees BAC, ICC, etc A new structure for building control Emphasis on competence, compliance and verification A 10 further SI's expected before summer recess







### Implications for products sector

Part 5 includes provisions relating to construction products: All construction products made available on the UK market should be regulated.

The BSA requires – Construction products to be safe. Create a statutory list of 'safety critical' construction products. Introduces new liabilities on materials producers for defective products

- 15 years back and forward.

In addition to the existing product safety regulatory regime.

Creates "building liability orders" and amends the Defective Premises Act 1972.







### Implications for products sector

**OPSS** product regulator Part 5 also gives the Secretary of State the power to regulate construction products for the whole of the United Kingdom.

To ensure that it remains fit for purpose.

Creates a new National Regulator for Construction Products within the Office of Products Safety and Standards.

OPSS sits within DBT, DLUHC will retain responsibility for construction products policy and DLUHC Ministers will remain accountable to Parliament.


